4. Requests for a specific space will not be accepted; placement will be made based on availability.
5. Sellers may set up on Friday, June 19 starting at 7 AM at the Bay and 12 PM at Taylor Park. .
6. Vendors must see a Festival Coordinator before setting up their area. Coordinators can be located at the St. Albans For the Future table as marked on your map.
7. All Vendors are responsible for keeping the area in their lot clean.
